Report on activities 2022

In July 2021 the committee of the Commission was reconstituted as:

Secretary: Wilfrid Hodges (Okehampton, England)

Treasurer: Seyed N. Mousavian (Tehran, Iran and Loyola University, Chicago IL).

This committee is still the same in 2022 and 2023.

In our planned activities for 2022 we undertook to develop the ALC website, noting: 'At present there is no place one can look for a list of people with an interest in Arabic Logic, or an indication of their range of interests, or perhaps a note of their recent publications in the field.
